#### CODE COMPLIANCE COMMITTEE

Happy Summer Everyone,

The Code Compliance Committee has been at work for you. We have as of this date identified 71 properties within Grandmont #1 neighborhood where simple yard maintenance has not been met based on the Ordinance of the City of

Detroit. This includes front and backyards as well as side lots, vacant properties and businesses. Please be advised theses homes and other land parcels have been turned over to the proper authorities for their disposition. This could mean that the property owner could be fined and a possible seizure could take place if the city deems the property and its owner is in total neglect. Please keep up on your yard maintenance. If you are a senior citizen or have a major disability that prohibits you from maintaining your property, please ask for help. We all need to remember that this is "OUR" neighborhood. A good clean neighborhood leads to higher home values, better self-esteem and shows we take great pride in our homes and neighborhood.



The ordinance states any nuisance vegetation over 8 inches tall is in violation and subject to penalties. I understand that since we only have yard waste pick-up that some may only cut their grass every other week. I have taken this into consideration, and have watched these properties and can verify that it has been a lot longer than every other week. Right now I am a one-man committee and need some volunteers to help. I also call upon the block captains for their help in identifying properties on their blocks that need attention or that the properties have become maintained. #### Ordinance-Section 22-2-45—Time limits for approved containers to remain at curb side

Properly stored domestic solid waste shall be collected by Advanced Disposal. Owners and/or occupants of residential structures who receive curbside collection shall place approved containers on a berm area not earlier than 6:00 p.m. on the day before collection and shall remove the same not later than 9:00 p.m. on the day of collection

- A person who violates this Code is responsible for a blight violation and is subject to a civil fine of one hundred dollars (\$100.00) for the first offense.
- ♦ A person who violates this Code is responsible for a blight violation and is subject to a civil fine of three hundred (\$300.00) for the second offense.
- A person who violates this Code is responsible for a blight violation and is subject to a civil fine of five hundred dollars (\$500.00) for the third offense.
- ♦ A person who violates this Code is responsible for a blight violation and is subject to a civil find of one thousand dollars (\$1,000.00) for the fourth or subsequent offense.
