<u>Crime Prevention Tip:</u> <u>Handling Your Keys</u>



BE SAFE
DURING THE
HOLIDAYS!

The "key" to crime prevention may lie in the palm of your hand, literally! Here are a few security measures that we can take as it relates to our door/car keys and key rings:

- ALWAYS have your keys in-hand and ready when entering/exiting your home or car. You do not want to linger outside, making yourself and easy target.
- Do NOT hide spare keys immediately outside of your home. It is no longer clever to hide spare keys in the mailbox, under a welcome mat, or under the rocks and plants. You are better off leaving a spare with a trusted neighbor.
- Do NOT place personal identification information on key rings (e.g., address, name, telephone, etc.). In the event that your keys are lost you don't want the finder knowing where you live.
- In the event that you do lose your keys, be sure to change your door locks ASAP.

KEEP YOUR DOGS LEASHED OR SECURE

There have been reported attacks by Pit Bulls left to roam freely in Minock Park (Auburn). Please call Animal Control if dogs are not secure or 911 if an dog attack occurs.

City Ordinance: Sec. 6-2-6. Dog Restraint

- (a) It shall be the duty and the responsibility of the owner of any dog to kept the dog on their owner's property.
- (b) It shall be unlawful for any owner to allow any dog to stray on public or private property, other than the private property of the owner, unless held properly by a leash or under restraint, provided, that police dogs accompanied by their handler while actively engaged in an activities for which such dogs are trained are not subject to this prohibition."

Under the current ordinance, Animal Control has the authority to issue a ticket to the owner for violations of the ordinance.

If the house or suspected squatters are in North Rosedale Park, contact Clarenda Webb (313-330-7844). If the house or suspected squatters are in Grandmont, contact Diane Patterson (313-836-3736).

Please do all that you can to maintain the yards of the vacant houses on your block – pick up trash and flyers, and do what you can to make the house look occupied.
