### **DEAR NEIGHBORS,**

Farewell to 2021! Welcome to the new year and I hope that my last letter as NRPCA President finds you and your family safe, healthy, and happy. With any luck, in the last few weeks you had a chance to get some downtime and take advantage of opportunities to rest and relax. As we turn the page to a new chapter, I'm tremendously grateful for your support, wisdom, and guidance over these last two years. The pandemic has affected us all and dragged on much longer than we ever anticipated. My heart continues to go out to all our neighbors that have been impacted by the unprecedented challenges of this last year and my appreciation to those neighbors who are working on the frontlines to contain COVID-19. We will be living with the consequences well beyond 2022 as we continue to address the political, health, and economic impact of the virus. However, as I've spoken with many of you over the last few years, I think we've all come to have a better appreciation for how this crisis has driven a renewed understanding of the important role of our neighborhood and our aspiration to be a beloved community where we care for one another and strengthen our bonds.

The NRPCA Board of Directors accomplished much together in 2021 and I thank them for their dedication and commitment. We held on to a call for action that kept us laser focused on the future we all must work together to create. It hasn't been without challenge. Twenty-three months into this pandemic, we still had to cancel or postpone events, meet remotely, and pivot some of our favorite neighborhood traditions to an online or outdoor format. Despite these obstacles, we've been able to stay grounded as a neighborhood when the only constant in this turbulent year was change. This happened because of our amazing neighborhood volunteers. Many of them are recognized in this issue of the Tattler and it's because of their love of this neighborhood that North Rosedale Park has been able to thrive. The entire neighborhood owes a special debt of gratitude to Elizabeth Cooper, Beverly Frederick, and Billie Newsom. These "fantastic volunteers" went above and beyond for our community and stepped up to manage the Community House until the Board could hire Ericka Browning, our new Community House Manager. Together they oversaw long overdue upgrades, renovations, and maintenance.

It was a privilege to work with so many Board members that care deeply about this neighborhood. Thanks to the experience and wise counsel of Immediate Past President, Bill Frey, we had the continuity of leadership on NRPCA policies across several years. Whenever something needed to be done, the neighborhood could always count on Board members, Elizabeth Cooper, Beverly Frederick, Karen Graham, Sarah Hulett, Theresa Glenn, Chris Krupa, and Eric Willingham to volunteer without hesitation. I'm grateful to Marcia Bonner and JaNae Harrison for documenting NRPCA meetings and correspondence. When we began to look at opportunities to have safe outdoor events again, our Vice President, James Martin, led the development of the summer concert series in the park. Thanks to the efforts of our Membership Secretary, Chelsea Neblett, we were able to stay connected with many of you. I'm especially thankful for the North Rosedale Park Block Captains. They've always been our support system and point of connection. However, during 2020 and 2021 they also served as our neighborhood first responders and made sure that the Board had current

information about community needs. Much gratitude to NRPCA Treasurer, John Gumbel, who was recognized in last month's Tattler, for his years of dedication and service. With all these wonderful volunteers we were able to concentrate on making sure the neighborhood got through another year of the pandemic relatively intact.

As residents of North Rosedale Park, we had to renew our connection with one another in new ways. Through partnerships with the Detroit Symphony

Orchestra and Michigan Opera Theatre we were fortunate to bring outdoor concerts to the neighborhood for safe enjoyment by many residents. Youth sports also returned to the park in 2021 and the collaboration with the Detroit Institute of Arts provided us with the opportunity to have a path of outstanding cultural reproductions around the park for everyone's enjoyment. To celebrate the 100-year anniversary of the first homes built in the neighborhood, the North Rosedale Park History Book launched with resounding success. Without this extraordinary project, the NRPCA would have had a much more difficult year financially as book sales bolstered the organization's finances. The Board is grateful to the dedication of the NRPCA Legacy Committee for their vision and leadership.



The NRPCA was also able to continue actively advocating with decision makers on policies that would improve the quality of life in our neighborhood. This included participating in meetings with Mayor Duggan, Councilman Tate, State Representative Stephanie Young, and other leaders about issues such as the Grand River Streetscape, speed bump installations, the DWSD Water and Sewerage Upgrades and most recently the proposed Asphalt Plant, which would bring a potential environmental hazard too close to the Grandmont Rosedale neighborhoods. We modeled a way of working that demonstrated the importance of neighborhood collaboration to tackle big problems.

When my husband and I moved to North Rosedale Park 27 years ago, we saw beautiful houses, a walkable neighborhood with young people playing in the park. We knew right away that we were buying more than a house. We were choosing a community of neighbors. It's the belief in the power of community and service that influenced my decision to take on the role once again as NRPCA President. I didn't think in my wildest dreams that I would be serving during a pandemic, but I was able to draw on my time as President during 2009, when the economic downturn significantly threatened our neighborhood as a guidepost. When the country went into lockdown on March 13, 2020, our work at NRPCA shifted to one priority – financially-safeguarding the Community House and Park. Therefore, in every President's Letter over the last two years, I advanced three goals to organize the work of the Board: 1) Provide stronger governance and financial stewardship for the park and Community House; 2) Grow our membership and foster a sense of community; and 3) Support actions that keep our neighborhood beautiful and safe during the pandemic.

A legacy is only powerful when it provides a path to the future and who we need to be for the next generation of North Rosedale Park residents. I look forward to working with our new NRPCA leadership to make that path happen and encouraging you all to get involved.

## 2022 ABSENTEE BALLOT PROCEDURES

North Rosedale Park Civic Association Members in good standing (has paid 2022 dues or are Life Members) are eligible to vote in the 2022 election of the Board of Directors to be held on January 14, 2022. Members will be voting on candidates for the positions of president, vice president and four (4) directors. Due to COVID-19, NRPCA is offering three ways for eligible members to vote this year; "in-person" via curbside voting, absentee, or online.

Eligible members may vote "in-person" from your car at the Community House, 18445 Scarsdale St., on Friday, January 14, from 6-8 p.m. Residents will pull into the circle drive, have their name/address checked against the membership roll, and will receive a paper ballot to vote. All residents participating in curbside voting must remain in their vehicle, and wear a mask properly at all times.

If an eligible member is unable to appear in person at the polling place during the hours designated for voting, the member may obtain an absentee ballot from the Membership Secretary in advance of the election. Absentee ballots must be requested by Sunday, January 9. The ballot must be delivered to the Community House before the election closes at 8PM on Friday, January 14, 2022. Ballots are sent by request only to a current member and should not be duplicated. Due to COVID-19, NRPCA will offer online voting via the voting service, [Election Buddy](#). For full information and instructions on how to vote online, please visit [www.nrpca.org/vote](http://www.nrpca.org/vote). To vote online, residents must "opt-in" and fill out the online voting request form found at [www.nrpca.org/vote](http://www.nrpca.org/vote). The online voting sign-up form must be completed by Sunday, January 9. Residents will have their name/address checked against the membership roll, and once confirmed as in good standing (has paid 2022 dues or are Life Members) will receive a unique link to vote via email and/or text on Wednesday, January 12. Online ballots must be cast by 8pm on Friday, January 14. If more than one person will vote in the household, EACH person must sign up in order to receive a unique link to vote. **IF YOU SIGN UP TO VOTE ONLINE, YOU WILL NOT BE ABLE TO VOTE IN-PERSON TO ENSURE ONLY ONE VOTE IS CAST PER PERSON.**
